## Lyndeborough Board of Selectmen Meeting Minutes Dec. 2, 2020 FINAL

#### I. Call to Order:

Chairman Chamberlain called the meeting to order at 6:00 p.m.

#### **IV.** Community Forum and Public Comment:

Jessie Salisbury said they would like to establish a fund for the Memorial Park in the Village. Plans include removing the picket fence that is protecting the historic bricks and coming up with another solution. They plan to discuss this topic at their upcoming meeting. Resident Leo Trudeau volunteered to do the work at no cost to the town. Mrs. Salisbury inquired if there might be funds available for the material.

#### **Old/Tabled Business:**

#### High Speed Internet Connectivity Update

The Town met via Zoom with Carol Miller from the Division of Economic Development, Director of Broadband Technology for New Hampshire. Ms. Miller supplied a template titled, Request for Information, from the two carriers that service Lyndeborough: TDS and Consolidated Communications. This is the first step in the process. Per RSA regulations, they have 60 days to reply. They need 25MB download and 3MB upload. If they do not respond within the 60 days or cannot supply the above-mentioned speeds, then the Town can then use an RFP to find another provider. Options for bonding and financial obligations for the carrier or Town were briefly mentioned.

VOTE Chairman Chamberlain made a motion, Selectman Douglas seconded to send a request for information from TDS Telecom and Consolidated Communications regarding the broadband connectivity that they provide to the Town of Lyndeborough. Roll Call: Chairman Chamberlain, yes; Selectman Douglas, yes. Motion passed 2-0.

#### b. New Business:

#### 2020 Encumbrances

The Board reviewed the request for encumbrances and asked questions.

# VOTE: Chairman Chamberlain made a motion to accept the 2020 Encumbrances as presented as \$394,650.00. Selectman Douglas seconded the motion. Roll Call: Chairman Chamberlain, yes; Selectman Douglas, yes. Motion passed 2-0.

#### Police Dept. Tablets and Docking Station Extended Warranty Discussion

The total would be \$3,238.00 for both units for a 3-year and a 4-year extended warranty. It was discussed to consult Alan Treadwell from Twin Bridge Services if he can provide any type of extended warranty and do this work.

This topic will be on the December 16, 2020 meeting agenda.

#### Twin Bridge Services – 2020-2021 Agreement

T/A Boland said he was very satisfied with Alan' Treadwell's work. They provided a tremendous service and saved the Town a lot of money, \$15,500.00. Chairman Chamberlain agreed and added they helped tighten up the Town's security.

The package included the 2020 service agreement notes for a comparison. It was noted that \$6,218.00 of that is for annual subscriptions, which we have to pay either way. Twin Bridge supplied a credit from last year.

VOTE: Selectman Douglas made a motion to allow T/A Boland to sign the agreement with Twin Bridge Services as written for \$15,557.00 on behalf of the Board of Selectman. Chairman Chamberlain seconded the motion. Roll Call: Chairman Chamberlain, yes; Selectman Douglas, yes. Motion passed 2-0.

#### V. Town Administrator Report

The new cruiser is in and put into service for the Town. After a discussion, it was agreed to put the 2016 cruiser on <u>www.municibid.com</u> for a reserve of \$5,500.00, which is more than the potential trade-in estimate.

VOTE: Chairman Chamberlain made a motion to authorize T/A Boland to put the 2016 police cruiser on www.municbid.com with a minimum bid of \$5,500.00. Selectman Douglas seconded the motion. Roll Call: Chairman Chamberlain, yes; Selectman Douglas, yes. Motion passed 2-0.

The budget at 91% of the year is 83% spent. The revenue at 91% of the year is at 94.96%, but room and meals has not been included as of this date.
